The school should be conducted in the medium and at the same place as sanctioned by Section 41 (5) of the Karnataka Education Act, 1983. No transfer and transfer of school will be allowed for 5 years after permission is granted. Usually only one transfer is allowed. In case of transfer/handover after this period, fresh registration at the new location should be obtained. 5. As per the Karnataka State Registration of Societies Act 21 of 1960 Ordinance No. 9 of 1957 Act 13, the accounts up to the previous line (BII 31st March) should be submitted to the Registrar of Societies and the documents recorded. As per instructions of Government Order No. ED 113 SES 2005 Bangalore, dated 20th March 2005, basic land, recruitment of teachers and all other facilities should be provided in accordance with the additional departments. 11. Teachers with prescribed and qualified qualifications should be recruited as per departmental rules. If any teacher is recruited who does not have the prescribed qualification as per the rules, immediately dismiss him and hire a teacher who has the appropriate qualification. 12. Government Notification No. ED.104 S.E.G.2005 dated 2005 for every teaching/non-teaching staff to be recruited in the school. As per instructions dated 12-01-2006 service records containing service details are opened and entries are made and confirmed from time to time. 13. Service security should be provided to the teachers and staff working in the school as per the government order dated 12.01.2006. 14. If the institution has been transferred and the school has shifted since the commencement of this school, the new registration for the said school should have received first recognition and recognition from time to time as per the Education Act. 15. /157/20 (1) 5 /2014 : 26-07-2014 as per the instructions Hon'ble Commissioner of Police should have taken action as per the instructions given to the school management boards to carry out guidelines on 09 aspects in the interest of the safety of children in the school. 16. All safety measures should be taken as per rules. 17. R.T.E. The school must be registered under 18. No corporal punishment should be given to school children. 18. Check the installation of fire hydrants and mention in the report, precautionary measures should be taken to free the school building from fire and electrical accidents and the directions should be followed without fail. 20. A no smoking notice board should be compulsorily placed within 200 meters of the school. 21. Registration is compulsory for schools in existence after the Education Act 1983 came into force and should have been registered. 22. According to the report of the Education Coordinator, the school has very low enrolment/attendance and to increase the enrolment in the next academic year. Failure to do so will result in immediate cancellation of the order. 23. The instructions in the order issued by the Transport Department regarding the maintenance of school vehicles shall be followed. 24. The stairs leading to the upper floors of the school should not be narrow. If safety walls are not constructed at each floor or very small walls are constructed, precautionary measures should be taken in this regard. The last party should ensure that there are 5 Audi barrier walls. Grilles should be installed so as not to interfere with the ventilation and lighting system. This recognition is applicable only if all the above conditions are fulfilled. Failure to do so will result in immediate cancellation. 25. To teach children studying in classes 1 to 5, teachers must have passed the Khijachikkubidi Iturbhutunathi Khijana (Khiekhi) examination. (Date : 09-06-2014) and the governing body should recruit the teachers who have passed the examination. 26. The Hon'ble Karnataka High Court in Writ Petition: 14363/94 and judgment passed on: 02.07.2008 in several cases heard together, considering SLP 18139-18163/2008 filed by the State Government in the Hon'ble Supreme Court as Civil Appeal 5166-5190/2013 After being transferred to the Constitution Bench, the judgment passed on: 06.05.2014, the petition filed by the Associated Management on: 19.02.2015 came up for hearing and was finally disposed of by the Tribunal on Writ Petition: 55106/2014 dated: 28.04.2015. In which the interim order issued by the court on 22.02.2015, 20.05.2015 as per instructions and Commissioner's 5.Shi.E. Bangalore vide Notification Date: 10.04.2015 and Memorandum Date: 16.05.2015 schools registered in Kannada medium for class 1 to 5 should submit application for conversion to English medium, if they are schools ordered by the Honorable Commissioner. Clause of clause (9) shall not apply. 27. Compulsory obtaining of Child Safety Measures, Building Safety, Fire Safety Certificates as per Rule 5A and Rule-7 Schedule of Karnataka Educational Institutions Rules 2018 and vide Hon'ble Supreme Court Writ Petition No:483/2004 28. Publication of next year's fees in S.A.T.S of the school as per audit report 29. Compulsory teaching of Kannada as a first or second language as per departmental rules. 30. Karnataka Educational Institutions shall maintain a minimum enrollment of students as per Rule 41(9) of the Karnataka Educational Institutions Accreditation Rules 1999 Government Notification No: ED 131 Misc 98 Dated: 04-11-99. 31. Comply with all the accreditation rules as per Karnataka Education Act and no false information should be given, failing which accreditation will be withdrawn as per rules.
